

**WRITTEN CONFIRMATION & RETRACTION**

1. On the following occasions, I made various allegations against XL Results Foundations Pte Ltd and/or Mr Roger Hamilton:-
  - (i) in a document dated 20 March 2005 addressed to Craig Marshall and Paul Coates.
    - (a) paragraph 3 – *“[Roger] is a ruthless, shrewd and calculating man totally driven by money”*;
    - (b) paragraph 11 – *“[Roger] just seems to want to win at all costs regardless of destroying anyone”*.
  - (ii) in a document dated 15 May 2005 addressed to Esmeralda McNutty.
    - (a) *“... I realized if [Roger] did that to me that he that he [sic] doesn't give a shit about absolutely anyone. Yes he talks about social enterprise and collects money saying it but its just all a lie. ... for all his lies and hurt he has done to me and many other people who put their money in and didn't get anything in return.”*
  - (iii) in a document dated 15 May 2005 addressed to Jeni Middlehurst.
    - (a) *“... If I issue a statement what can I say “Oh I resigned from [XL Results Foundations Pte Ltd] because the charity was non-existent even though the company said for two years it would give money and when I mentioned it I was thrown out of the office by the police after three years working with [Roger] and the company”*
  - (iv) in a document dated 15 May 2005 addressed to Ajit Benjamin
    - (a) *“Things have flared up in Singapore I think Roger is desperate. He's been getting anonymous emails (which I think the pressure is on) and clients have been getting emails from people. It's all true but he is trying to scare people. Everyone wants their money back.”*
  - (v) in a document dated 19 May 2005 addressed to Esmeralda McNutty
    - (a) *“... I notice that [XL Results Foundation & Roger] take no responsibility for the fact no money has gone to charity and everyone wants their money back.”*
    - (b) *“... [Roger] is a coward and after he saw me on Friday night he was like a beaten dog.”*
    - (c) *“to be honest [Roger] would be petrified in court facing me and if it came out what they had done to me being a so-called social enterprise it would be outraged [sic].”*

- (vi) in a document dated 21 May 2005 addressed to Esmeralda McNutty.
- (a) *"... I also believe that [Dave Rogers] will manipulate the situation against me."*
- (vii) in my 2<sup>nd</sup> Affidavit filed on 28<sup>th</sup> September 2005 in MC Suit 15447 of 2005/G:
- (a) paragraph 8 – *"many people were taken in by [XL Results Foundations Pte Ltd's] marketing tool."*
- (b) paragraph 9 – *"I discovered that the [XL Results Foundations Pte Ltd's] did not intend to carry out the promises made through Roger and there was no charitable intent at all in giving to the underprivileged children and to save the endangered species. I was very disturbed when I realized that representations were made to the public at large and members were led to joining [XL Results Foundations Pte Ltd's] as life members and contributed financially for a good cause when in fact it was not carried out by the [XL Results Foundations Pte Ltd's]."*
- (c) para 11 – *"..... could no longer be associated with a man (or company) that was blatantly misleading his (its) membership (or life members). The life members all believed they were supporting charities but they were not. ....I was embarrassed by the Defendant's Roger's promises that never eventuated and it was morally wrong to mislead its members who believed that the Defendants were committed to making a difference and was a social enterprise."*
2. I admit that all the allegations set out in paragraphs 1(i) to 1(vii) above are untrue and/or inaccurate, and I unreservedly retract the same.
3. I further undertake that I shall:-
- (i) forthwith cease using XL Results Foundation Pte Ltd's Life Membership database and/or any Life Members' contact information and/or details, as these information are confidential; and
- (ii) not approach, by any means (verbal or otherwise), any of XL Results Foundations Pte Ltd's staff, country partners and/or speakers, either to threaten them, persuade them not to partner XL Results Foundations Pte Ltd, persuade them to leave XL Results Foundations Pte Ltd's employ and/or to not speak at any of XL Results Foundations Pte Ltd's events.
