**AFFIDAVIT**

I, Roger James Hamilton (NRIC No. S6883456B), of 8 Jalan Mutiara #12-07, The Montana, Singapore 249188, do solemnly and sincerely affirm and say as follows: —

1. I am the Chairman of the Defendant, which is a company registered in Singapore, and dealing in the business of technical, vocational and commercial education and mail order agencies. I am duly authorized to make this affidavit on behalf of the Defendant.

2. The facts and matters deposed to hereinafter are either within my personal knowledge or are derived from documents in my possession. Insofar as the matters deposed to are within my personal knowledge, they are true. Insofar as the

matters deposed to are not within my personal knowledge, they are true to the best of my information and belief.

3. I make this affidavit in support of the Defendants' application to amend their Defence & Counterclaim filed on 26 July 2005.

***The Proposed Amendments***

4. The proposed amendments are set out in the draft Amended Defence & Counterclaim, a copy of which is attached to the application filed herein.

5. Since the time of filing and service of the Defence, new relevant and/or material facts and particulars have come to light and/or have been clarified. Therefore, the proposed amendments are made to highlight these material facts and particulars.

6. In particular, the proposed amendments are to:-

- (a) highlight and to particularize nature of the various email and/or documents which the Plaintiff had, in breach of her obligations, sent out to various third parties; and
- (b) identify the aforesaid third parties to whom the Plaintiff had sent the documents and/or email.

7. The reason for how and why these documents and/or email had only come to light presently is set out below.

***How The New Facts And Particulars Arose And/Or Came To Light***

8. The Plaintiff was a former employee of the Defendants. In the course of her work and employment, she was loaned a laptop by the Defendants.

9. This laptop was in her sole possession and was used exclusively by her during the entire time when she was still in the Defendants' employ, and was only returned to the Defendants' solicitors on or about 25 May 2005, almost 2 months after her employment with the Defendants ceased. A copy of the Defendants' solicitors' letter dated 25 May 2005, acknowledging receipt of the said laptop from the Plaintiff is annexed hereto and marked "**RJH-30**".

10. After the laptop was returned, we found that the same was not able to boot properly, and that we were unable to retrieve any data and/or information from the laptop on our own.

11. As we suspected that the Plaintiff had used the said laptop to send out email and/or documents to various parties in breach of her obligations under the Severance Agreement dated 1 February 2005 and Supplemental Agreement entered into between the parties in or around mid April 2005, we sent the laptop to computer forensics experts for data recovery.

12. Our efforts have proved to be rather successful. The computer forensics experts have recently been able to recover a part of the data, email, and/or documents contained in and/or sent from the said laptop, which prove that the Plaintiff had, in breach of her obligations, sent out to various parties email and/or documents relating to the following matters: -

- (a) information relating to her history within the Defendants;
- (b) financial details and company information of the Defendants;
- (c) information, allegations and/or details about Roger Hamilton which are detrimental, negative, and/or harmful to the Defendants and/or Roger Hamilton; and
- (d) information and/or details about the Plaintiff's relationship with Roger Hamilton which are detrimental, negative and/or harmful to the Defendants and/or Roger Hamilton.

Copies of these recovered documents and/or email are annexed hereto and marked "**RJH-31**".

13. I have been informed by the computer forensics experts that apart from the documents and/or email referred to above, there may be more information, data and/or email (which may be material and/or relevant to the present case)

contained in the laptop that have still not been recovered. The computer forensics experts are still working on the laptop and are making every effort to recover the same. They will also be preparing a report of their findings once they have completed their work on the said laptop.

14. I verily believe that the proposed amendments will not prejudice the Plaintiff whatsoever. This is particularly so as parties have not even been given directions for the filing of their respective list of documents and their respective witnesses' affidavits of evidence-in-chief.

**Conclusion**

15. In the circumstances, I humbly pray for an order in terms of the Defendants' application herein.

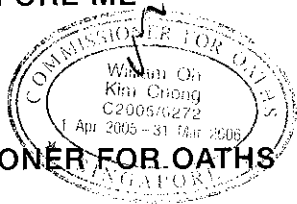



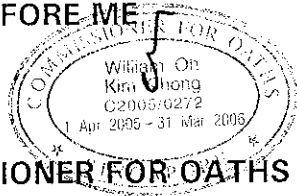

I'm still hanging in there and trying to keep my dignity and professionalism under traumatic circumstances. Paul thank you for meeting me on Tuesday, I would have collapsed otherwise. What a humiliating experience and a low point in my life. I cannot express the shame I felt when the pol. came out.

R and I had a disagreement behind closed doors. I expressed my concern about an Australian licence being sold and said it was morally wrong under the circumstances with everything going on. I probably shouldn't have even spoken to him. Anyway there was no scene and I was not hysterical.

I have realised he will put money before absolutely anyone or anything even his children. I am not defending his action he is what he is a ruthless, shrewd and calculating man totally driven by money. The pressure is getting to him. I realise I was a valuable commodity until I started to question things I thought were wrong. The concept was so brilliant but the motives were solely driven by money.

I was more surprised that D who had appeared to be my friend sided with Roger to call the police. I trusted D. When R's lawyer told him he shouldn't have called the police out on me R then blamed D. They then started to bicker with each other. It was embarrassing.

The pol. were surprised when they arrived it must have been a pathetic scene. I looked tiny with a pink poncho on and was sitting there with the two of them standing over me. I was weeping and shaky but kept my composure and grace. I think the police were annoyed to be called out and probably thought I was an abused woman.

My Lawyer advised me to go back the next day with a pol. escort. I did and of course all my files had gone. I told the staff to let R know I was in the office and D appeared shortly after I had gone. It was very sad. The staff was helping me to pack and very upset by it all. I was crying and so were they. I am angry at the trauma these guys have caused. They have now tried to charge me with trespassing and theft (I have an old laptop at home I work on). They are trying to get me on trumped up charges to discredit me - vengeful staff member etc. Every other staff member that ever left was also badmouthed, behaviour I would tell R was unnecessary. Now it's my turn but definitely more dramatic and very sad. I have a good Lawyer to deal with all this madness.

All charges have since been dropped as advised by their lawyer. It's ridiculous I didn't want a severance package or anything I just wanted to get out. It was decent of R in the first place to offer it but it went sour when he escalated it to the lawyer. R got angry when he couldn't string the payment out. The lawyer told him to pay me out. Even though I don't want anything I now need to get the severance/salary to pay for my Lawyer to protect me. The situation is ironic.

My family don't know in Australia they would be very concerned. It's so wrong after working like I did for three years.

I am trying to be strong and don't want anyone to know about the pol. coming out. Although I haven't done anything wrong it has really traumatised me. At the shops yesterday I saw the pol. And thought they were coming to take me away. I was so shaky. Next time you see me perhaps you could make light of the situation with some black humour. Humour will help me heal. I'll see a counsellor about it as well. All that I am as a woman and a person and they went to such a level with me.

As my friend I am sure you are horrified about the situation. I need myself and you guys to stay cool. There are a group of LM who are working on a case. If the locals feel there is something wrong let them deal with it.

I'm praying there will be no more onslaughts coming my way. I want them to leave me alone. Penny resigns this Tuesday which will cause more problems and freak the LM out further. I had and still have no intention of doing anything wrong or speaking ill of either of them. I want to appreciate the opportunities I was given and the work on the magazine. I don't even hate R just wonder why someone is like that. He just seems to want to win at all costs regardless of destroying anyone. I realise now why there are no long term friendship in his life. I won't be destroyed though and if my back is against the wall I will fight back.

I'm both amazed and proud I have been able to complete the magazine under such adversity. Its sounds dramatic but it took me days to pull myself back together. Now I work from a Starbucks with Azlin the graphic designer.

I am grateful to the few people I can confide in and I trust. I am not playing the victim nor do I wish too. Part of this problem is because I am strong and determined and I stand up for myself and other people. They won't break me and I will rebound to a higher level.

I think there must be many cracks appearing for such irrational behaviour and for R to snap. He is usually very calm under pressure. That independent email broadcast from the UK seems to be the start of it all. Once Penny leaves there will be no long term staff it's falling apart at the seams.

The magazine goes to print on Wednesday and on Friday I will be heading off to Sri Lanka. It will put it all this rubbish into perspective. The Sri Lankan's have nothing but they are gentle, friendly and kind.

I am blessed with friends and the ability to be able to write and express myself. I've been focussed on my articles and it's given me some peace of mind. Writing this to the two of you has got some of the anger out.

Please read this and delete. It's off the record as my lawyer tells me. How ridiculous ☺

Dear Life Member,

I am sorry to have to bring this to your attention, but we have had a number of Life Members forward on information to us in the last few months that we have dealt with on a case by case basis. However, it has reached a level where we now want to clarify these matters with all Life Members.

Here at XL Results Foundation we continue to work hard each month to grow the value of our work for the benefit for all entrepreneurs in Asia Pacific and especially to our Life Members. You will have seen various developments throughout this first four months of this year, and you will be hearing shortly from Roger on the many upcoming developments we are committed to through 2005 and 2006.

We will always hold ourselves to the highest levels of integrity and ethics as we grow, as we expect all our Life Members to through our Code of Conduct. This is what allows us to build a trusted network that we can all be proud of. We will also defend ourselves fully against anyone who attempts to cast doubts on our integrity through rumors or innuendo.

Over recent months, we have received numerous reports from Life Members that an individual (who is not a Life Member, or XL customer) has been in contact with them, and made unsubstantiated and untrue claims and/or allegations about XL Results Foundation and Roger which are clearly meant to disparage his integrity and the integrity of the organization. We have identified that person and shall be commencing legal proceedings to protect and/or enforce our rights and reputation.

In addition, since March 2005, offending emails were mailed to XL Life Members from at least three different Yahoo accounts, to spread rumors about XL Results Foundation, Roger and myself. The "authors" of these offending emails - "James Tan", "David Lu" and "Anthony Yap", claim to be Life Members. However, none of them are, and neither have they ever been

customers of XL or attendees at any events. The creator of these Yahoo email accounts, however, has access to the Life Membership database and has been selecting the Life Members to target the messages at. We have commenced legal proceedings to track the Yahoo accounts back to source.

In particular, the latest offending email sent by one "Anthony Yap" on 5 May 2005 to some of our Life Members stated that a report had been filed with one Mr Desmond Ow of the Commercial Affairs Department ("CAD") alleging wrongdoing by Roger Hamilton, Chairman of XL Group, and myself. We have spoken with Mr Ow (who has been copied in on this email) and obtained Mr Ow's confirmation that no investigation is being carried out against Roger Hamilton and myself in respect of any alleged wrongdoings.

We take an extremely serious view against such baseless and untrue allegations which are aimed at disparaging the reputation, integrity and character of XL Results Foundation, Roger and myself, and we will use the full extent of the law to defend our reputation and integrity. This we will do now, and at all times in the future.

Thank you to all the Life Members who have brought these communications to our attention. If you have received any such emails, but have not let us know, we have been asked by our lawyers to collect any such information, so please do forward them on to us. If you would be more comfortable, you can also forward them directly to our lawyer, Wilson Wong of Drew & Napier LLC, at [wilson.wong@drewnapier.com](mailto:wilson.wong@drewnapier.com).

My apologies that for legal reasons we are not able to disclose more at this stage, but we will update you once we have brought this matter to a close.
